Call to Order

Agenda Item 1: Minutes of the February 27, 2024 Standing Monthly Board Meeting

Mr. Townsend's presentation included an overview of the financial status of the Plan as of the end of 2023, as well as projections of the Plan's financial status through Calendar Year 2025, including assumed premium rate adjustments necessary to meet the Plan's stated funding objective.
