The Mississippi Department of Finance and Administration's (DFA) Office of Procurement and Contracts issued an Invitation for Bids (IFB) (RFx 3160006430) on February 21, 2024, to secure a vendor to provide Heat Ventilation Air Conditioning (HVAC) water treatment services for properties owned and operated by the State of Mississippi in the Jackson and Biloxi areas. These services are to be provided for the Office of Capitol Facilities within DFA. The awarded contract term will be three (3) years with two (2) optional renewal years. All services provided for this contract shall be performed under the direct supervision of experienced and qualified Contractor personnel. Contractor shall be responsible for DFA's HVAC water treatment program. Contractor shall provide all equipment necessary for services.

In response to the IFB, DFA received two (2) sealed bids on and before the submission deadline (March 25, 2024) from the following vendors:

- 1. NCH Corporation dba ChemsearchFE;
- 2. Zee Company.

DFA opened bids on March 25, 2024. The bids were ranked as follows:

The DFA, Office of Procurement and Contracts, reviewed each bid submitted. After review, it was determined that both submitted bids were responsive to the IFB and met the minimum qualifications set forth in the IFB. Based on review, and having submitted the lowest, responsive and responsible bid, the DFA Office of Procurement and Contracts recommends the contract for HVAC Water Treatment Services be awarded to NCH Corporation dba ChemsearchFE.
