#### Section 1.2.1 Building Walkthrough Tour

DFA shall provide guided building walkthroughs on Tuesday March 5, 2024, beginning at 9:00 a.m. Participating bidders are encouraged, but not required, to attend the guided building walkthroughs. Participating vendors shall meet DFA staff at 8:45 a.m. in the Woolfolk Building, 501 North West Street, lobby (facing Lamar Street). Participating bidders will be limited to two (2) representatives per bidder. The tour shall begin promptly at 9:00 a.m., participating bidders are encouraged to arrive early.

The buildings included on the tour will represent the different types of buildings and elevators to be serviced under the awarded contract. No video or photography shall be allowed during the tour. No questions will be answered during the tour. All questions are to be submitted by 5:00 p.m., March 8, 2024, in accordance with the specifications as stated below in Section 1.3 Questions and Answers.

Questions must be received no later than 5:00 PM CST, on or by March 8, 2024, to ensure a response by DFA. Responses to questions will be posted to the DFA website at <a href="https://www.dfa.ms.gov/bids-and-rfps-notices">https://www.dfa.ms.gov/bids-and-rfps-notices</a> under "Active Procurements" as an amendment to the IFB on March 13, 2024. Questions received after March 8, 2024, may be considered for response, although there is no guarantee as to if or when a response will be provided. It is the Bidder's sole responsibility to regularly monitor the website for amendments and/or announcements concerning this IFB.
