

STATE OF MISSISSIPPI QUALIFIED PROVIDERS OF EMERGENCY COMMODITIES, EQUIPMENT, AND SERVICES LIST

This is a list of potential providers of commodities, equipment, and services that are generally needed in emergency situations. In most cases, there are no contracts established but these vendors have indicated a willingness to provide prices and information about availability if contacted during an emergency situation. Government entities are urged to review this list and become familiar with the products and vendors so they will be better able to meet needs during an emergency. Upon the declaration of an emergency and as needs are identified and defined, the buying entity will review the qualifications, products, and services of those on the Qualified Providers of Emergency Commodities, Equipment, and Services List to determine which provider(s) are considered the best qualified for the specific requirement. The buying entity will then attempt to obtain at least two quotes or proposals and will purchase or enter into contract with the provider that is able to offer the greatest value to the buying entity, taking into consideration such issues as cost, availability, service level, location, urgency, etc. (Please note that a few of these firms do hold State of Mississippi Multiple Award (Negotiated) Contracts, but it is still important to attempt to obtain at least two price quotes prior to ordering). This list will be updated as additional providers are identified.
