

During the 2015 legislative session the Mississippi Legislature passed House Bill 1127, called the “Iran Divestment Act of 2015.” This bill calls for the identification of companies engaged in investment activities with Iran, providing funds, goods or services valued at \$20,000,000 or more in the energy sector of Iran. This includes any company or entity that provides oil liquefied natural gas tankers or products used to construct or maintain pipelines used to transport oil or liquefied natural gas for the energy sector of Iran.
