and from appropriations from the State's General Fund made pursuant to Section 1 of Senate Bill 3065, 2019 Regular Session of the State Legislature, Section 2 of Senate Bill 3065, 2019 Regular Session of the State Legislature, Section 1 of House Bill 1730, 2020 Regular Session of the State Legislature, Section 1 of Senate Bill 2971, 2021 Regular Session of the State Legislature, Section 2 of Senate Bill 2971, 2021 Regular Session of the State Legislature, and Section 49 of Senate Bill 2971, 2021 Regular Session of the State Legislature (collectively, the "Acts") (collectively, the "Series 2022A Act") and a resolution adopted by the State Bond Commission on August 11, 2022 (the "Series 2022A Resolution").

SECURITY: Pursuant to the Act, the Series 2022A Bonds shall be general obligations of the






