IV. Update on Project Status – Gilda Reyes, CCID Program Director

High/Lamar Street Improvements (GS# 390-001) — completed, working on closeout documents; Highland Drive (Museum Blvd) (GS# 390-002) — completed, now has subgrade failure, in the process of repairs; President Street Improvements (GS# 390-003) — Schematic Design phase complete, moving into Construction Document phase; Mississippi Street Improvements (GS# 390-004) — Construction got postponed from May 2, 2022 to June 6, 2022 and construction is going well; State Street Improvements (GS# 390-005) — in the construction document phase, arborists did tree studies and determined that there are trees that need to be removed; East Capitol Street Sidewalk Improvements (GS# 390-006) — Still in construction phase, Hemphill Construction has been hired through Brown and Root to repair damages to the basement in front of the Lamar Life building; North Street Improvements (GS# 390-007) — Construction Document phase complete, put on hold due to other project construction; and, John R. Lynch Street Improvements (GS# 390-008) — is moving into the Construction Document phase and the goal is to start in January.

V. Update on CCID Financials – Gilda Reyes, CCID Program Director

There is currently enough revenue stream to cover all projects. The revenue stream is consistent at 6% and CCID receives approximately \$850,000 each month. There are approximately 3 loan payments left on the 7 million borrowed.
