High/Lamar Street Improvements GS# 390-001 and Highland Drive Improvements (Museum Blvd.) GS# 390-002 are complete. President Street Improvements GS# 390-003 Schematic Design phase complete, next Design Document phase. East Capitol Street Sidewalk Improvements GS# 390-006 Notice to proceed (NTP) February 1, 2022, estimated end of summer completion. Mississippi Street Improvements GS# 390-004 will receive bids on February 24, 2022, State Street Improvements GS#390-005 stakeholder meeting scheduled for January 24, 2022, and North Street Improvements GS# 390-007 are all in the design development phase and will continue with the construction phase in the first quarter of 2022. John R. Lynch Street Improvements GS# 390-008 contract signing/ kick off scheduled.

V. Update on CCID Financials – Gilda Reyes, CCID Program Director

High/Lamar Street Improvements GS# 390-001, Highland Drive Improvements (Museum Blvd.) GS# 390-002 and East Capitol Street Improvements GS# 390-006 are all funded from the borrowed 7 million. Bond bill gave \$2,000,000.00 for the John R. Lynch Street Improvement project GS# 390-008, CCID has committed extra funding for the project. All project total estimated 30 million, currently a little more that 20 million in the bank. The revenue stream is consistent at 6% and CCID receives approximately \$800,000 each month.
