2025 Premium Rate Changes

Effective January 1, 2025, the plan will implement a 5% premium rate increase for all health coverage options. This increase will affect Medicare eligible and non-Medicare eligible retirees.

Your Life Insurance coverage

As a retiree under the State and School Employees' Health and Life Insurance Plan, you may have elected to continue life insurance coverage under the Plan. If so, please consider the following:

- Your coverage is provided by the State and School Employees' Health and Life Insurance Plan. Minnesota Life Insurance Company, an affiliate of Securian Financial Group, Inc. is the underwriter of your group coverage for the State and School Employees' Life Insurance Plan.
- This plan is a term life policy with no cash surrender value.
- You remain covered for the life of the policy as long as your premium is current.
- Your benefits do not decrease as you get older.
- Monthly premiums will increase each year until the age of 70. Once you reach the age of 70, your monthly premium will no longer increase annually.
- Beneficiary designations are maintained by Minnesota Life (Securian); therefore, any beneficiary inquiries must be made by contacting Minnesota Life (Securian) directly at 877-348-9217

Turning 65 soon?

When you become Medicare eligible, your retiree health plan benefits will automatically transition to secondary coverage to Medicare effective the first day of the month of your 65th birthday. Your premium will also be adjusted based on your retiree and dependent selections. As your secondary coverage, your retiree health plan will cover only medical and hospital visits at 20% and you will no longer have pharmacy benefits.

It's also important to know that becoming Medicare eligible does not automatically terminate your coverage as a retiree under the Plan. If you wish to terminate your coverage when you become Medicare eligible, you must send a written request to the Retiree Department at BCBCMS for proper processing. Coverage will terminate at the end of the month in which a written request is received by BCBSMS Retiree Department.
