Old Business

Chairman Upchurch recognized Mr. Richard Self, State Insurance Administrator with the Office of Insurance, who discussed the recent passage of HB 873 by the Mississippi Legislature, which removed the Board's authority to establish a tobacco surcharge. Mr. Self reminded the Board that a vote was taken during the March 25, 2015 meeting to revise the 2015 *Plan Document* to reflect HB 873's removal of the surcharge, but that the Board did not have a quorum at the time the vote was taken.
