Call to Order

The meeting was chaired and called to order by Ms. Laura D. Jackson, Chairman of the Board.

Agenda Item 1: Minutes of the September 26, 2018 Standing Monthly Board Meeting

The minutes of the Board's standing monthly meeting of September 26, 2018 were provided to all Board members for their review prior to the meeting. A motion was made by Mr. Kelly Hardwick for the Board to approve the minutes as presented. Mr. Mark Formby seconded the motion. The motion passed by a 6-0 vote, with members Formby, Haire (designee for member Chaney), Hardwick, Higgins, Mayfield and Rankins voting affirmatively.

Agenda Item 2: HIPAA Exemption Election

Chairman Jackson recognized Mr. Richard Self, State Insurance Administrator with the Office of Insurance, who advised that staff recommends that the Board continue to elect exemption of the State and School Employees' Health Insurance Plan from certain federal regulations under the Health Insurance Portability and Accountability Act (HIPAA). Mr. Self explained that although the Board has consistently elected to generally comply with the intent of the HIPAA requirements voluntarily, it has nonetheless voted annually to exempt the Plan from regulation under these provisions for the past twenty years. He advised that should the Board elect to continue this exemption for 2019, notification of this election would be filed with the U. S. Department of Health and Human Services, and likewise provided to participants as a part of the *Plan Document*. Mr. Hardwick moved to approve the exemption election. The motion was seconded by Mr. Formby. The motion passed by a 6 – 0 vote, with members Formby, Haire, Hardwick, Higgins, Mayfield and Rankins voting affirmatively.

Agenda Item 3: Financial Statements

Chairman Jackson recognized Ms. Latasha Holmes, Director of Budget and Accounting with the Office of Insurance, who briefly reviewed the financial statements for the State and School Employees' Life and Health Insurance Plan for the month of September 2018. Copies of the financial statements were provided to Board members for their review prior to the meeting. No action was required or taken by the Board on this item.
