Call to Order

The meeting was chaired and called to order by Ms. Liz Welch, Chairman of the Board.

Agenda Item 1: Minutes of the September 27, 2023 Standing Monthly Board Meeting

Chairman Welch announced that the minutes of the Board's September 27, 2023, standing monthly meeting had been provided to all Board members for their review in advance of today's meeting. A motion was made by Mr. Mike Chaney for the Board to approve the minutes for September as presented. Mr. Mark Formby seconded the motion. The motion passed by a 7-0 vote, with members Chaney, Formby, Gavin, Hardwick, Higgins, Rankins, and Smith voting affirmatively.

Agenda Item 2: HIPAA Exemption Election

Chairman Welch recognized Mr. Bert Emrick, State Insurance Administrator, who advised that staff recommends that the Board continue to elect an exemption of the State and School Employees' Health Insurance Plan from certain federal regulations under the Health Insurance Portability and Accountability Act (HIPAA). Mr. Emrick explained that although the Board has consistently elected to generally comply with the intent of the HIPAA requirements voluntarily, it has nonetheless voted annually to exempt the Plan from regulation under these provisions for the past twenty-five years. He advised that should the Board elect to continue this exemption for 2024, notification of this election would be filed with the U. S. Department of Health and Human Services, and likewise provided to participants as a part of the *Plan Document*. Mr. Hardwick moved to approve the exemption election. The motion was seconded by Mr. Formby. The motion passed by a 7-0 vote, with members Chaney, Formby, Gavin, Hardwick, Higgins, Rankins, and Smith voting affirmatively.

Agenda Item 3: Financial Statements

Chairman Welch recognized Mr. Bert Emrick, who briefly reviewed the financial statements for the State and School Employees' Life and Health Insurance Plan for the month of September 2023. Copies of the financial statements from September 2023 were provided to the Board members for review prior to the meeting. No action was required or taken by the Board on this item.

Agenda Item 4: General Schedule

Chairman Welch recognized Mr. Bert Emrick, who reviewed the schedule of major activities and actions to be taken by the Board for the next several months.

Chairman Welch again recognized Mr. Bert Emrick, who presented the draft 2024 Plan Document. Mr. Emrick reminded Board members that the Plan Document provides a comprehensive description of the operation and administration of the State and School Employees' Life and Health Insurance Plan, and includes a listing of covered, as well as excluded, services and benefits. Mr. Emrick discussed in detail a summary of the proposed changes to the Plan Document, including but not limited to the recently approved 2024 benefit changes. A motion was made by Mr. Chaney to approve the 2024 Plan Document as presented. Mr. Hardwick seconded the motion. The motion passed by a 7 – 0 vote, with members Chaney, Formby, Gavin, Hardwick, Higgins, Rankins, and Smith voting affirmatively.
