Call to Order

The meeting was chaired and called to order by Ms. Liz Welch, Chairman of the Board.

Agenda Item 1: Minutes of the March 27, 2024 Standing Monthly Board Meeting

Chairman Welch announced that the minutes of the Board's March 27, 2024 standing monthly meeting had been provided to all Board members for their review in advance of today's meeting. A motion was made by Mr. Mark Formby for the Board to approve the minutes for March as presented. Mr. Mike Chaney seconded the motion. The motion passed by a 6-0 vote, with members Burkhalter, Chaney, Formby, Gavin, Rankins, and Smith voting affirmatively.

Agenda Item 2: Potential Benefit Changes for Calendar Year 2025

Chairman Welch recognized Mr. Bert Emrick, State Insurance Administrator, Office of Insurance, who outlined the process and schedule for consideration of proposed Plan benefit changes for 2025, and briefly discussed the list of potential changes. Mr. Emrick advised that the Board will need to indicate which of the potential benefit changes listed they would like for the staff to analyze, and explained that other proposed changes could be added to the list if the Board so desired. The following potential benefit changes were discussed:

- 1. Consider changes to prescription drug benefits.
 - a. Coverage tiers
 - i. Additional copayment amounts.
 - ii. Deductible amounts for higher class drugs, i.e. Brand and Specialty.
 - b. Coverage for obesity treatment.
 - c. Adding Prudent Rx and True Accumulation options to help lower pharmacy costs.
- 2. Consider changes to medical benefits.
 - a. Deductible increases
 - b. Copay increases and/or additions.
 - i. Specialty provider office visit copay.
 - ii. Mental health provider office visit copay.
- 3. Consider eliminating the precertification penalties for participants.
- 4. Legislative changes that could affect the benefit plan.
