Agenda Item 1: Minutes of the January 22, 2025 Standing Monthly Board Meeting

Lynn Townsend, FSA, MAAA, the Board's Consulting Actuary, who provided preliminary projections from his actuarial analysis of the State and School Employees' Life and Health Insurance Plan for calendar year 2024, including historical and projected trend rates, and projected premium rate adjustments needed to meet the Plan's state funding objective. Mr. Hardwick made a motion to approve that the preliminary projected increase for FY 2026 will be 6.5% rather than 5%. The motion was seconded by Mr. Chris Burkhalter, then passed unanimously with members Burkhalter, Browning (designee for member Chaney), Wiggins (designee for member Evans), Formby, Gathings, Hardwick, Rankins, and Smith voting affirmatively.

Agenda Item 3: Financial Statements

Chairman Welch recognized Mr. Bert Emrick, who briefly reviewed the financial statements for the State and School Employees' Life and Health Insurance Plan for the previous two months. Copies of these financial statements were provided to the Board members for review prior to the meeting. No action was required or taken by the Board on this matter.
