### Call to Order

Ms. Cindy Bradshaw, Trust Administrator, called the meeting to order at approximately 11:19 a.m. and announced that a quorum was present.

## Approval of the Minutes of the Board Meeting on June 17, 2021

The minutes of the June 17, 2021 Board meeting were provided to Board members for their review. A motion was made by Mr. Phil Hardy to approve the minutes as presented. Mr. Ryan Beard seconded the motion. The motion passed unanimously.

#### FY 2021 Claims and Performance Review Audit

Ms. Bradshaw recognized Mr. Chris Shaman, Deputy Director, who briefly reviewed the results of the claims and performance review conducted by Strategic Claims Direction, LLC (SCD), of CCMSI's performance as the third party claims administrator for the Mississippi State Agencies Self-Insured Workers' Compensation Trust. A copy of SCD's report entitled Claims and Performance Audit Report for the Mississippi State Agencies Self-Insured Workers' Compensation Trust, July 2021, was distributed to Board members for their review. Mr. Shaman advised the Board that CCMSI posted high levels of administrative performance and had met or exceeded all contractual performance standards. No Board action was necessary on this matter.

### **Financial Statements**

Ms. Bradshaw introduced Ms. Angela Inman, Deputy Director who briefly reviewed the final financial statements for the Mississippi State Agencies Self-Insured Workers' Compensation Trust for Fiscal Year 2021 and the financial report through the month of September 2021.
