The Mississippi Department of Information Technology Services is requesting assistance from the Department of Finance and Administration / Bureau of Building, Grounds and Real Property Management, regarding . . . failing roof on the State's Eastwood Data Center, which houses many of the State's mission critical IT applications. The presence of moisture and pooling water constitutes the most detrimental scenarios for the electronic equipment . . . and is requesting approval for expenditure from the Capital Expense Fund for FY15; and, proceeding with project for said emergency, with the Professional obtaining bids in an on-going project, etc.

NOTE: Code 27-103-303 allows up to \$500,000.00 for any single emergency with a cap of \$2,000,000.00 per fiscal year. This request is for \$500,000.00 of the FY15 Capital Expense Funds. The Office of Capitol Facilities Declaration is attached. The Department of Finance and Administration Emergency Certificate is attached. Letters have been drafted for distribution to the seven entities named in the statute for notification of expenditure from the Capital Expense Fund.

#### DFA DECLARATION OF EMERGENCY CERTIFICATE

I, Kevin J. Upchurch.	, Executive I	Director of the	Department of Fi	nance and A	dministration,	do hereby n	nake the follo	wing findings a	ınd
declarations pursuant	to authority	provided in Se	ections 31-7-1(f)	and 31-7-13	(i), Mississip	pi Code of	1972:	0 0	

- (1) An emergency is being declared as set forth below for . . . assistance with failing roof on the State's Eastwood Data Center, which houses many of the State's mission critical IT applications. The presence of moisture and pooling water constitutes the most detrimental scenarios for the electronic equipment . . . .
- (2) In the opinion of the Department of Finance and Administration, the delay incident to giving opportunity for competitive bidding would be detrimental to the interests of the State. This is based on letter serving as the Declaration of Emergency from Craig P. Orgeron, Ph.D., Executive Director of the Mississippi Department of Information Technology Services, dated January 16, 2015.
- (3) As per Section 31-7-13(j), Mississippi Code of 1972, ... If the governing board or the executive head, or his designee, of any agency of the state shall determine that an emergency exists in regard to the purchase of any commodities or repair contracts, so that the delay incident to giving opportunity for competitive bidding would be detrimental to the interests of the state, then the provisions herein for competitive bidding shall not apply . . .
- (4) As per Section 31-7-1(f), Mississippi Code of 1972, "Emergency" shall mean . . . any circumstances . . . when the immediate preservation of order or of public health is necessary . . . or when immediate restoration of a condition of usefulness of any public building . . . appears advisable. . . . or when the delay incident to obtaining competitive bids could cause adverse impact upon the governing authorities or agency, its employees, or its citizens . . . .
- (5) The repairs and replacements are being processed under GS Number 527-015 entitled "Data Center Improvements" for the Mississippi Department of Information Technology Services.
- (6) The procedures provided in the Bureau of Building, Grounds and Real Property Management Procedure Manual regarding emergencies are being complied with, as well as the Code Sections referenced above.
- (7) Procedures for obtaining bids will now commence between the Bureau of Building Grounds and Real Property Management, the Professional Sanderson Engineering, Inc., and the Using Agency, for subject project.
- (8) Expenditures will be made from FY15 Emergency Capital Expense Fund.

RE: Emergency Declaration and Assistance

Dear Mr. Kornbrek:

ITS is declaring an emergency and requesting your assistance with the failing roof on the State's Eastwood Data Center, which houses many of the State's mission critical IT applications. The presence of moisture and pooling water constitutes the most detrimental scenarios for the electronic equipment that operates within the controlled Data Center environment. While both ITS and BOB have been dealing with water and leaking issues around the 'penthouse' of the Data Center since ITS took possession of the building, the new presence of water over the raised floor space was just discovered in early December 2014. The following outlines information and actions taken since that time.

- December 4, 2014 ITS and UMMC staff discovered water leaking from the concrete ceiling on the 2<sup>nd</sup> floor of the data center. Notification about the leak was sent to BOB.
- December 5, 2014 A protective tarp we placed over the leaking area to protect UMMC's EPIC servers and equipment.
- December 8, 2014 Randy Turner, BOB, reported to ABC about the leak
- December 11, 2014 ABC responded acknowledging the situation
- December 15, 2014 Independent Roofing came to site, inspected the roof, and determined that the roof was deteriorating. Several corrosive holes were found and patched with silicone.
- December 18, 2014 Independent Roofing recommended that a new roof be installed
- December 23 24, 2014 Leaks continue in the data center after rains
- December 25, 2014 ITS met again with Independent Roofing to determine best temporary fix to stop leaks
- December 26, 2014 Independent Roofing came back on site and discovered more corrosive holes in the roof. More silicone was applied to seal these holes
- December 29, 2014 Request submitted to Independent roofing to install a temporary tarp over the entire eastern side of the Data Center
- December 30, 2014 Temporary tarp installed
- January 14, 2015 Joint Meeting between DFA, ITS, Roof Installer, Manufacturer, and Architect to inspect damage and ongoing issues

Given these facts, ITS believes that allowing the State's mission critical systems to run in a facility that continues to leak each time there is rainfall is negligence on our part. The risk to the State is too great to delay remediation and repairs. ITS is requesting your assistance invoking the warranty with the

manufacturer of this roof as well as your assistance in determining, in the most expeditious manner possible, a replacement roof that will meet the specifications requested in the initial design for a weatherproof facility that can withstand not only normal weather but up to a F4 tornado. With the warranty, bidding for a suitable replacement may not be required. In the event that bidding is required, to follow the normal advertisement and bidding process would be detrimental to the agency due to the time delay in obtaining necessary support and purchases.

ITS is requesting emergency flexibility and funding up to \$500,000 to cover the expenses listed below:

- All costs associated with the temporary purchase, installation, and any preventative measures to
  include covering the entire Eastwood Data Center with tarps in an effort to protect the systems
  and infrastructure from any additional moisture and/or contact with water. ITS agrees with BOB
  that the manufacturer should cover the expenses for these preventative measures.
- All costs associated with the installation and materials of a new roof that is rated to support a data center facility, as well as the removal and disposal of the existing roofing material.
- All costs associated to remedy any unforeseen damages to the underlying roof, waterproof membrane, supports, etc. that are a result of the current roofing situation.

Under 31-7-1(f) and 31-7-13(j) of the Mississippi Code of 1972, I am asking that DFA declare that an emergency exists. We are requesting that DFA acting through the Bureau of Building, Grounds and Real Property Management invoke the roof warranty and assist ITS in determining the best replacement for our current roof.
