(a) FARMLAND LEASES:

Consider a request from the Mississippi Department of Wildlife, Fisheries and Parks to amend its Lease Agreement with Paul Graber, Lessee, for farmland at Black Prairie Wildlife Management Area in Columbus, Mississippi. Due to unforeseen conditions for some of the land which was originally bid for lease on February 26, 2015, some fields will not be suitable for farming for the 2015 crop year. Because of this, MDWFP wishes to allow the Lessee the option of farming other lands at Black Prairie Wildlife Management Area, which were not originally scheduled to be farmed this year. The details of the Amendment are as follows:

- Lessee will not plant or harvest any crops on fields 12, 13, 17, and 18, containing roughly 97.66 acres, more or less, as was originally bid on February 26, 2015.
- Lessee will be allowed to plant and harvest crops on field 33, containing roughly 98.5 acres, more or less.
- This Amendment will be in force and effect only for the 2015 crop year.

All other terms and conditions of the original Lease Agreement will remain the same.
