The Department of Public Safety is requesting assistance from the Department of Finance and Administration / Bureau of Building, Grounds and Real Property Management, regarding the Administration and Driver Services Buildings chiller due to water in the oil caused by leaking refrigerant lines within the system.

The Bureau of Building, et al, is requesting approval for \$500,000.00 expenditure from the Capital Expense Fund for FY17; and, proceeding with project for said emergency, with the Professional obtaining bids for the above mentioned project.
