Ms. Irvin presented the following:

1. Jackson State University (JSU) requested to use the Master Lease Purchase Program to finance the purchase of musical instruments for the band. JSU solicited bids for the musical instruments. Six (6) responses were received. Three (3) of the bids were declared non-responsive. One (1) response was declared non-responsive because the vendor is not able to provide silver plated keys for several of the instruments; the second (2nd) response was declared non-responsive because the vendor failed to bid on all items and is not able to provide silver plated keys, while the third (3rd) response was declared non-responsive because the vendor could not provide silver plated keys and the vendor lacked the quality and longevity of the instruments required. JSU evaluated the remaining three (3) responses and accepted the lowest bid, based on lowest price and the bid that met the specifications. JSU requested approval to award to Taylor Music, Inc., in the amount of \$463,638.00, from 05/04/2016 to 02/23/2017. Mr. Phillips made a motion to approve contingent upon the issuance of a purchase order or an award letter by the agency. Mr. Snowden seconded and the motion carried.
