Alcorn State University is requesting assistance from the Department of Finance and Administration / Bureau of Building, Grounds and Real Property Management, regarding . . . mechanical failures of the Cation exchange treatment system which has resulted in major deterioration of the plant due to acid corrosion . . . has caused widespread mechanical and infrastructure failures in the majority of buildings on the campus . . . boilers, chiller systems, hot water distribution systems, and fire suppression systems are not functioning to their life expectancy etc.

The Bureau of Building, et al, is requesting approval for \$500,000.00 expenditure from the Capital Expense Fund for FY17; and, proceeding with project for said emergency, with the Professional obtaining bids for the above mentioned project.

NOTE: Code 27-103-303 allows up to \$500,000.00 for any single emergency with a cap of \$2,000,000.00 per fiscal year. This request is for \$500,000.00 of the FY17 Capital Expense Funds. The Alcorn State University Declaration of Emergency is attached. With PPRB approval herein, the Department of Finance and Administration Emergency Certificate will be drafted, along with the letters for distribution to the seven entities named in the statute for notification of expenditure from the Capital Expense Fund.

Declaration of Emergency

- I, Dr. Alfred Rankins, Jr., President of Alcorn State University, do hereby make the following findings and determinations pursuant to authority provided in Section 37-7-13 (j), Mississippi Code of 1972, Annotated.
 - (a) That there is an emergency at the Alcorn State University Water Treatment Plant and Water Distribution System located at 1000 ASU Drive #509, Alcorn State MS 39096.
 - (b) That, this emergency is due to recent mechanical failures of the Cation exchange treatment system which has resulted in major deterioration of the plant due to acid corrosion. Since the plant was constructed in late 2006, it has been "off-line" for the majority the time during the last eight years from 2008-2016. The plant's off-line status has resulted in the inability of the university to provide treatment and water softening processes for the water supply, which is extremely hard in this region. This extreme water hardness has caused widespread mechanical and infrastructure failures in the majority of buildings on the campus due to excess calcium build-up. Key mechanical systems all over the campus including, but not limited to boilers, chiller systems, hot water distribution systems, and fire suppression systems are not functioning to their life expectancy due to calcification of the piping systems since the water cannot be softened due to the plant being off-line. Furthermore, this emergency is compounded because water distribution systems on the campus are also compromised because of aging infrastructure relating to malfunctioning water wells and holding tanks.
 - (c) That, Dr. Jeff Posey, Associate Vice President of Facilities Management for the university, has made a determination that the current condition of the water treatment facility is an emergency situation after careful review of a preliminary engineering report prepared by Engineering Service Consulting Engineers dated 7/26/2016 utilizing Mississippi Bureau of Building Discretionary Funds in project #GS-101-306 (Water Plant Improvements)
 - (d) That, delay incident to giving opportunity for competitive bidding would be detremintal to the best interest of the state.
 - (e) Further, that plans for emergency repairs have been prepared and should be used to obtain written quotes.

By means of this Emergency Certificate, we request the Bureau of Building, Grounds and Real Property Management to take the necessary steps for immediate repairs to the Water Treatment Plant and Water Distribution System.

DFA DECLARATION OF EMERGENCY CERTIFICATE

I, Laura D. Jackson, Executive Director of the Department of Finance and Administration and State Fiscal Officer, do hereby certify to the following findings and declarations pursuant to authority provided in Sections 31-7-1(f) and 31-7-13 (j), Mississippi Code of 1972:

- (1) An emergency is being declared as set forth below for Alcorn State University regarding mechanical failures of the Cation exchange treatment system which has resulted in major deterioration of the plant due to acid corrosion.
- (2) In the opinion of the Department of Finance and Administration, the delay incident to giving opportunity for competitive bidding would be detrimental to the interests of the State. This is based on Declaration of Emergency from Dr. Alfred Rankins, Jr., President of Alcorn State University dated August 22, 2016.
- (3) As per Section 31-7-13(j), Mississippi Code of 1972, . . . If the governing board or the executive head, or his designees, of any agency determines that an emergency exists in regard to the purchase of any commodities or repair contracts, so that the delay incident to giving opportunity for competitive bidding would threaten the health or safety of any person, or the preservation or protection of property, then the provisions in this section for competitive bidding shall not apply
- (4) As per Section 31-7-1(f), Mississippi Code of 1972, "Emergency" shall mean . . . any circumstances . . . when the immediate preservation of order or of public health is necessary . . . or when immediate restoration of a condition of usefulness of any public building . . . appears advisable . . . or when the delay incident to obtaining competitive bids could cause adverse impact upon the governing authorities or agency, its employees, or its citizens . . .
- (5) The repairs are being processed under GS# 101-306 entitled "Water Plant Improvements (EMER)" for Alcorn State University.
- (6) The procedures provided in the Bureau of Building, Grounds and Real Property Management Procedure Manual regarding emergencies are being complied with, as well as the Code Sections referenced above.
- (7) Procedures for obtaining bids/quotes will now commence between the Bureau of Building, Grounds and Real Property Management, the Professional, and the Using Agency, for subject project.

(8) Expenditures will be made from the Capital Expense Funds.
