The Mississippi Department of Corrections is requesting an exemption to the purchasing regulations in accordance with the following findings and determinations pursuant to authority provided in Section 31-7-13 (j) of the Mississippi Code 1972 Annotated. Those findings are as follows:

- 1. That there is an emergency at the Mississippi State Penitentiary, Hwy 49 West, Parchman, Mississippi, which involves deficiencies in Unit 29 and Unit 30 kitchens. Due to recent failures of Unit 29 kitchen, which led to non-compliance with the Mississippi Department of Health during an inspection in July 2016, Unit 29 kitchen was closed until fully compliant, leaving only one (1) functioning small kitchen in Unit 30 to provide daily meals for over 3,300 inmates. The Unit 30 kitchen also has aging infrastructure and equipment issues that need to be rectified.
- 2. That I, as Commissioner, have made a determination that the repairs at Unit 29 and Unit 30 kitchens constitute an emergency situation inasmuch as it is absolutely necessary that meals be provided to our state inmates as a constitutional right.
- 3. That delay of making necessary repairs would be detrimental to the best interest of the state, specifically the preparation and delivery of meals to over 3,300 inmates, which under current circumstances, could threaten the health of those inmates and subject the state to litigation for failure to fulfill a constitutional obligation.

The immediate need for the repairs and equipment replacement in Unit 29 and Unit 30 kitchens are critical to the orderly running of the institution; therefore, following the bid requirements as proscribed would negatively affect the department's ability to rectify the closure conditions at MSP. Further, evaluation of the existing conditions has been completed for emergency repairs, including, but not limited, to replacing all kitchen equipment, mechanical

and/or domestic pipe insulation, and freezer/cooler repairs. In complying with this request, a minimum of two written quotes were obtained on all kitchen equipment and pipe insulation.

By means of this Emergency Certificate, we request the Mississippi Department of Corrections be permitted to take the necessary steps for immediate repairs to the Unit 29 and Unit 30 Kitchens at the Mississippi State Penitentiary with the emergency purchase of the equipment as detailed.
