INOMAX is a pharmaceutical medical grade gas (nitric oxide) used to treat neonatal and adult patients for hypoxic respiratory failure associated with pulmonary hypertension. INO Therapeutics is the only vendor that has FDA approval for the inhaled form of the nitric oxide drug and the drug delivery system (for inhalation). The drug is necessary to administer in inhaled form for patients on ventilator support, as well as for some pulmonary hypertension therapies. This agreement was presented to and approved by IHL on 6/15/2017. UMMC has stated that this contract will be funded by hospital patient revenue. UMMC followed current regulations for sole source procurement.
