## ORDER STAYING PROTEST APPEAL

THIS MATTER, having come before the Public Procurement Review Board (PPRB) on Medical Transportation Management, Inc.'s (MTM) appeal of the Mississippi Division of Medicaid's protest decision, is hereby STAYED until such time as the Hinds County Chancery Court rules on Verida, Inc.'s petition for protective order in Cause No. 25CH1:23-cv-00479.

As a threshold matter, MTM timely filed its original protest pursuant to the language in Medicaid's Invitation for Bids. While the Rule 7-112 of the *PPRB OPSCR Rules and Regulations* provides parties seven days to protest following the notice of intent to award, Medicaid's Invitation for Bids specifically stated that the protest deadline was "no later than April 19, 2023." Thus, even though MTM's protest was filed nine days after issuance of the notice of intent to award on April 10, 2023, the protest was timely filed pursuant to the terms of the agency's solicitation document.

Rule 7-112.03 of the *PPRB OPSCR Rules and Regulations* stays the award of a contract when a protest is timely filed following issuance of a notice of intent to award. Where the protesting party requested the bid of a third party submitted in response to the solicitation being protested and the third party filed a petition for protective order in Chancery Court, the protesting party's protest rights cannot be extinguished until the petition for protective order has been ruled upon by the Court or otherwise resolved among the parties.

However, where an Agency has issued an Invitation for Bids, Rule 3-202.11.3 allows the agency to seek PPRB approval of the resulting contract and, once approved, to execute that contract even where a timely filed protest is pending *if* the petition has been pending in Chancery Court for more than 90 days and the Chancery Court has not ruled on the petition. Should the Agency choose to proceed under Rule 3-202.11.3, the Rule 7-112.03 stay is effectively lifted, but the protesting party's protest rights are not extinguished and continue to exist after contract execution.

In the present matter, MTM's protest rights at the agency have not been exhausted and this Board will stay the protest appeal until such time as all protest rights at the agency are exhausted. Following entry of a court order ruling on Verida's petition, the stay shall be lifted without further action from this Board, as follows:

 Should the court rule that no portion of Verida's bid may be produced to MTM, the agency shall provide a copy of the court order to PPRB. The stay will be lifted once PPRB has received the court order and no further briefing to PPRB regarding the protest appeal will be allowed.

- Should the court rule that any portion of Verida's bid may be produced to MTM, Medicaid shall produce the portion(s) of Verida's bid allowed by the protective order. Thereafter, Medicaid shall provide MTM a reasonable amount of time to supplement its protest at the agency. In no event shall MTM be provided less than seven calendar days to supplement its protest.
  - o Should MTM choose not to supplement its protest to the agency, the agency shall provide a copy of the court order, a copy of the notification the agency provided MTM regarding the deadline to submit a supplemental protest, and notification to PPRB that no such supplemental protest was timely received. Upon production of these documents to PPRB, the stay will be lifted and no further briefing regarding the protest appeal will be allowed.
  - Should MTM choose to supplement its protest to the agency, the agency shall issue a final protest decision after considering MTM's supplemental protest. The Agency shall provide PPRB a copy of the final protest decision, a copy of the court order, and - to the extent allowed by law – a copy of the documents produced to MTM in compliance with the court order. Upon production of these documents to PPRB, the stay will be lifted and:
    - The protest appeal will be dismissed as moot *if* the final protest decision affirms MTM's protest; or
    - The parties may supplement their briefs before the PPRB with only those issues arising out of the documents produced pursuant to the court order if the final protest decision denies MTM's protest. The supplemental briefing deadlines are as follows:

## **MTM Supplemental Protest Brief:**

3 business days following issuance of the final protest decision by Medicaid

## Medicaid and Modivcare Supplemental Response Briefs:

5 business days following filing of MTM supplemental protest brief

## MTM Supplemental Reply Brief:

2 business days following filing of Medicaid and/or Modivcare supplemental response briefs

A true and complete copy of any documents submitted to PPRB shall also be provided by email to each party's counsel of record.

PPRB delegates authority to the staff at the Mississippi Department of Finance and Administration (DFA) to amend this Order as needed to ensure the protest appeal is handled efficiently and effectively and the rights of all parties are preserved. PPRB further delegates authority to DFA staff to establish the time, date, and procedure for a hearing on the protest appeal once the stay has been lifted.

Nothing in this Order prohibits the agency from immediately seeking PPRB approval of the contract and, if approved, executing the contract as allowed by Rule 3-202.11.3. To seek such approval, Medicaid is required to submit the contract to the Office of Personal Service Contract Review at DFA pursuant to the deadlines established for submission of all personal and professional services contracts requiring PPRB approval.

Dear Ms. Wray,

The Mississippi Division of Medicaid's ("DOM") Final Decision in the MTM protest was not premature under MISS. CODE ANN. § 25-61-25(1)(b). That statute applies to public access to records held by a state agency. It is not a procurement statute and impacts the procurement protest process only to the limited extent expressly provided therein. Accordingly, this statute must be strictly construed in light of its very limited purpose which is solely to provide limited extensions of time to file a protest to an entity requesting production of competitive sealed proposals prior to the time it files a protest. Once the protest has been filed, the statute has no impact whatsoever on the time line in which an agency can issue a final decision.

Persons making a request for production of competitive sealed proposals after the notice of intent to award is issued by the public body shall have a reasonable amount of time, but in no event less than seven (7) working days after the production of the competitive sealed proposals, to protest the procurement or intended award prior to contract execution. However, in any instance where a person has filed for a protective order for a competitive sealed proposal and the court has not ruled on the protective order within ninety (90) days of filing, then the public body may proceed with awarding the contract without production of competitive sealed proposals and the contract may be protested after execution.

MISS. CODE ANN. § 25-61-25(1)(b).

On its face, the statute impacts the procurement protest process only in one limited instance that is specifically set out in the statute: where a notice of intent to award a contract has been issued, a public records request for competitive sealed proposals is subsequently made, and no procurement protest has been filed with the agency pending receipt of the documents. In that scenario, the statute allows an entity requesting a sealed competitive bid seven (7) working days after receiving the competitor's bid to then file a protest. If an intervening motion for protective order is filed and more than 90 days pass without a court ruling on the motion, the statute then authorizes the agency to move forward with awarding the contact, and any protest thereafter filed will be a protest of the contract rather than of the procurement itself.

Thus, under the plain language of the statute, an entity may seek a sealed competitive bid after the notice of intent has been issued and has no less than seven (7) working days after receipt of the documents to decide whether to file a protest of the procurement. If any party seeks a protective order with regard to the sealed competitive bids being sought and the Court has not ruled on the request for a protective order within 90 days, then the agency may go forward with awarding the contract and any protest thereafter filed will be a protest of the awarded contract.

This statute simply has no application here, and in no way does it render DOM's Final Decision premature. As pointed out in DOM's October 18, 2023, letter to Suzanne Hudson, a copy of which is attached, the time line is as follows:

April 5th: Public Record Request by MTM
April 10th: Notice of Intent to Award published
April 19th: Protest of Notice of Intent filed by MTM
May 5th: Motion for Protective Order filed by Verida
October 4th: DOM's Final Decision on Protest

MTM filed its public records request seeking the competitive sealed bid of Verida, who had been disqualified as a bidder on the NET IFB, five (5) days before DOM published its *Notice of Intent to Award the Contract*. MTM thereafter filed its Protest nine (9) days after the Notice of Intent was published and without waiting for the records it had previously requested to be produced. Subsequently, Verida filed a request for a protective order in Hinds County Chancery Court. DOM's Final Decision on the Protest was issued 153 days after the request for a protective order was filed. To date, the Chancery Court has not entered an order on the request for a protective order.

Under these undisputed facts, the statute is totally inapplicable to the factual situation before this Board. Accordingly, the Board should not enter any stay, remand or dismissal of MTM's appeal before this Board, but instead should proceed to consider the merits of MTM's appeal of DOM's Final Decision denying MTM's Protest.

There are five (5) reasons MISS. CODE ANN. § 25-61-25(1)(b) does not apply here. First, the statute only applies to requests for **competitive sealed bids**. As noted in DOM's disqualification letter to Verida, Verida's bid was never considered as a competitive bid because it failed to include all of the necessary parts as required by the IFB, i.e., independently audited financial statements. As such, Verida was immediately disqualified as a bidder, and Verida did not appeal its disqualification. Verida was not a competitive bidder as contemplated by the statute because it was disqualified before DOM considered the bids. Verida is simply irrelevant to any issue raised in MTM's Protest or appeal.

Second, the statute only applies to requests made **after** the notice of intent to award has been issued. MTM made its public records request five (5) days **before** the Notice of Intent was issued by DOM. Thus, the statute is inapplicable.

Third, MTM filed its Protest with DOM rather than waiting for production of the documents or resolution of the motion for protective order. The time extensions authorized by the statute apply **only** to the filing of the protest, which MTM has already done. Nothing in the statute or PPRB Rule 3-202.11.3 requires a pause when a protest has already been filed. If the legislature had wanted to impose a 90-day waiting period when a protest has already been filed, it would have put it in the statute. It did not. The statute simply does not address staying a protest because it does not contemplate that a protest was filed before receipt of the requested documents. PPRB cannot imply such a requirement into a statute where none exists. "In construing a statute, '[t]he entire statute must be construed together, and effect give to every

part of it, if it can be done without manifestly violating the intent of the legislature." *Rush v. Rush Health Systems, Inc.*, 359 So. 3d 1047, 1060-61 (¶ 46) (Miss. 2023) (citations omitted).

Fourth, even if the Board finds that the statute is applicable, DOM complied with the statute. DOM did not enter its decision on MTM's Protest **until 153 days** after Verida filed its request for a protective order. This is well more than the 90 days required by the statute. There is no mechanism in the statute or PPRB rules for this Board to issue a stay beyond 90 days. That 90 days has run, thus this Board does not have the authority to issue a stay.

Finally, public policy supports the inapplicability of the statute here. The purpose of the statute is to allow the party seeking documents to receive and review them before deciding whether to file a protest. It allows seven (7) days after the documents have been produced to file a protest. But, if after 90 days the Court has not resolved a pending request for a protective order, then the statute allows the awarding agency to go forward with awarding a contract which can then be protested **after** the contract is executed. Where, as here, the protest has already been filed, it is not possible for the agency to comply with the statute because PPRB Rule 7-112.03 prohibits the Agency from awarding a contract as allowed under the statute. Instead, that decision is redirected to this Board:

In the event of a timely protest, the agency shall not proceed further with the solicitation or with the award of the contract until the Public Procurement Review Board approves the determination that continuation of the solicitation or award of the contract without delay is necessary to protect substantial interests of the State.

Without permission from this Board, DOM cannot award the contract to ModivCare, yet the statute vests DOM with total authority to do so. DOM should not be put in the position of complying with the statute or the PPRB Rule because compliance with both is not possible under the position taken by PPRB counsel.

In this case, MTM chose to file its Protest without the Verida documents. The Protest must go forward. Neither MISS. CODE ANN. § 25-61-5(1)(b) (or any other statute) nor any PPRB rule have a requirement to stay a decision on a Protest while waiting for the resolution of a public records request for a sealed competitive bid. Implying a requirement that an agency wait indefinitely on the vagaries of a Court ruling on a request for a protective order merely encourages protesters to file spurious public record requests and then to drag out the process by refusing to sign off on required orders or endlessly negotiating over the wording of agreed orders because it is in the client's interest to delay. Rather, public policy demands that the bid process be both speedy and certain. Having an expeditious protest process serves that purpose. DOM's ruling on the Protest was not premature and this Board should rule on the merits of the Protest

Alternatively, and only if the Board determines that DOM's Final Decision was premature, then DOM requests permission pursuant to PPRB Rule 7-112.03 to immediately award and execute the contract with ModivCare pursuant to the *Notice of Intent to Award Contract*. DOM is currently operating under an emergency contract with MTM which is more expensive than the contract it intends to award ModivCare. It is, therefore in the best interest of the tax payers of the State of Mississippi to move forward with awarding and executing the ModivCare contract.

DOM provides the following information on response to your inquiry earlier today:

In response to the IFB at issue, DOM received three bids from MTM (the protestor), ModivCare (the winning bidder), and Verida. During its initial review of bids, DOM determined that Verida's bid failed to include financial statements required by § 1.8.2(5) of the IFB. As a result, Verida's bid was deemed non-responsive, and Verida was disqualified. Verida did not appeal this disqualification. Thus, Verida was not a competitive bidder on this project, because its bid was properly disqualified before bids were ever evaluated for purposes of making an award.

Subsequently, MTM filed a records request on April 5, 2023 requesting, among other documents, a copy of the sealed bid Verida submitted in response to the IFB. Although Verida was not a "competitive bidder" because its bid had been disqualified, the document nonetheless contained information that could be considered confidential or proprietary. Accordingly, DOM provided notice of the request to Verida as required by the Mississippi Public Records Act.

Shortly thereafter, on April 10, 2023, DOM published a Notice of Intent to Award the Contract stating that Modivcare was the winning bidder.

On April 19, 2023, MTM filed a Procurement Protest with DOM. On May 4, 2023, Verida filed a Petition for Protective Order. Although a hearing was held on this Petition October 4, 2023, no order has been entered by the Court and this Petition is still pending as of this date. DOM denied MTM's protest on October 4, 2023. This is 153 days after Verida's Petition for Protective Order was filed. It is also more than the ninety day "stay period" required by MISS. CODE ANN. § 25-61-5(b)(1):

...However, in any instance where a person has filed for a protective order for a **competitive sealed proposal** and the court has not ruled on the protective order within ninety (90) days of filing, then the public body may proceed with awarding the contract without production of competitive sealed proposals and the contract may be protested after execution.

Accordingly, in issuing its denial of MTM's protest on October 4, DOM fully complied with the requirements of Mississippi law for two

reasons. First, the ninety (90) day "stay period" required by MISS. CODE ANN. § 25-61-5(b)(1) does not apply here, because MTM's request for Verida's sealed bid was not a request for a competitive sealed bid. During the initial review, Verida's bid was deemed non-responsive, and it was disqualified, a finding that Verida did not challenge. DOM never considered Verida's bid for purposes of making an award. Thus, Verida's bid was never a competitive proposal within the meaning of the statute.

Second, even if Verida's bid could be considered a competitive bid for purposes of MISS. CODE ANN. § 25-61-5(b)(1), DOM still complied with the statue. Verida's Petition for Protective Order was filed May 4, 2023. DOM's denial of MTM's protest occurred on October 4, 2023, 153 days after the filing of Verida's Petition. This complies with the ninety day "stay period" even if it applied.

Finally, DOM notes MTM's request that all briefing and hearings on its appeal to PPRB be delayed while it seeks additional documents through a second, and possibly third, public records request to DOM. There is no statute, rule, or regulation that allows for such a delay, nor should one be granted in this instance even if any such discretion existed. MTM did not file a second public records request with DOM until October 5, 2023, as reflected in the attached document. That request was for communications to and from a variety of DOM personnel involved in the NET procurement, all of whom have long been known to MTM. There is no basis at all to suggest that this belated request for documents was related to "newly-discovered facts" as MTM alleges.

In addition, MTM's request was excessively broad. DOM attaches an e-mail string that reflects the public records request and DOM's response. Rather than deny the request outright, DOM has elected to allow MTM to cure its request by narrowing the scope, at which point, it can be processed as a proper request. As of today, MTM has failed to provide any information to DOM that narrows the scope of its request so that it complies with the public records statutes.

These proceedings should not be delayed based on late records requests that certainly could have been made in a timely manner, nor should any delay be allowed based on MTM's failure to serve requests that comply with the statutory requirements.

Dear Ms. Wray:

ModivCare Solutions, LLC ("ModivCare") is in receipt of the December 18, 2023 email correspondence from Suzanne Hudson in which Ms. Hudson stated, "DFA staff will recommend that PPRB stay the protest appeal in the non-emergency transportation procurement pending outcome of Verida's petition for protective order." The apparent basis for this recommendation being that the Hinds County Chancery Court "has not ruled on Verida's petition" for protective order. Id. ModivCare objects to this stay as it is improper and there is no basis for such a stay in statute or regulation; therefore, the PPRB should reject the recommendation to stay by the DFA staff.

As stated in ModivCare's initial November 15, 2023 brief filed with the PPRB, MTM's appeal of DOM's protest decision is nothing more than a delay tactic. As the incumbent Non-Emergency Transportation (NET) Brokerage Services vendor, any delay in this protest appeal process serves as a mechanism by which MTM can continue to be paid under a fee structure that DOM has acknowledged includes administrative and overhead fees that are "exorbitant."

The authority cited by the DFA staff for recommending the stay of proceedings is PPRB OPSCR Rules and Regulations Rule 3-202.11.3. DFA staff's reliance on this rule is misplaced and improper. Rule 3-202.11.3 provides a mechanism by which parties may protect the confidentiality of data submitted to a public agency when responding to IFB; however, Rule 3-202.11.3 also recognizes that state business cannot be held hostage by unwarranted delay tactics. Rule 3-202.11.3 is clear: "in any instance where a person has filed for a protective order for a competitive sealed proposal and the court has not ruled on the protective order within ninety (90) days of filing, then the public body may proceed with awarding the contract without production of the competitive sealed proposals and the contract may be protested after execution." The process outlined in Rule 3-202.11.3 is based upon the authority granted in Miss. Code Ann. § 25-61-5.

Miss, Code Ann. § 25-61-5 states:

Production of competitive sealed proposals in accordance with requests made pursuant to this section shall be no later than seven (7) working days after the notice of intent to award is issued to the winning proposer. Persons making a request for competitive sealed proposals after the notice of intent to award is issued by the public body shall have a reasonable amount of time, but in no event less than seven (7) working days after the production of the competitive sealed proposals, to protest the procurement or intended award prior to contract execution. However, in any instance where a person has filed for a protective order for a competitive sealed proposal and the court has not ruled on the protective order within ninety (90) days of filing, then the public body may proceed with awarding the contract without production of the competitive sealed proposals and the contract may be protested after execution.

Miss. Code Ann. § 25-61-5 (emphasis added). Based upon its plain language, Miss. Code Ann. § 25-61-5 authorizes DOM to award the contract to ModivCare if any petition for protective order has not been ruled on within ninety (90) days of filing.

The petition for protective order at the heart of this issue is one filed by Verida. Leaving aside the *paramount* fact that DOM disregarded Verida's bid, MTM requested records from DOM related to Verida's bid on April 5, 2023. Verida filed its petition for protective order on May 4, 2023. One hundred and fifty three (153) days later, on October 4, 2023, DOM denied the protest field by MTM and upheld its award of the IFB to ModivCare – an action they were plainly authorized by § 25-61-5 and Rule 3-202.11.3 to take. MTM engages in an interesting semantical argument on this issue – stating that while § 25-61-5 authorizes DOM to award a contract, it does not authorize DOM to rule on a protest. The PPRB should not be confused by this flawed logic – if DOM has the authority to award a contract, it naturally follows that it has the authority to deny a protest before awarding said contract.

Miss. Code Ann. § 25-61-5 also makes clear that it only applies to "competitive" proposals. As discussed in ModivCare's initial brief, Verida's bid was not a "competitive" proposal, because Verida's bid never progressed to the competitive stage of the procurement process. Pursuant to Rule 3-202.13.2, "[t]he acceptability evaluation is not conducted for the purpose of determining whether one bidder's item is superior to another but **only to determine that a bidder's offering is acceptable as set forth in the Invitation for Bids**" (emphasis added). DOM rejected Verida's bid and deemed it non-responsive during this "acceptability evaluation." Rule 3-202.13.3 makes clear that "[f]ollowing determination of acceptability as set forth in Subsection 3-202.13.2, . . . bids will be evaluated to determine which bidder offers the lowest cost to the State in accordance with the evaluation criteria set forth in the Invitation for Bids" (emphasis added). DOM determined that Verida failed to include the financial statements required by Section 1.8.2(5) of the 2023 IFB during the acceptability evaluation; thus, Verida's was not, and is not, "competitive." Miss. Code Ann. § 25-61-5 and Rule 3-202.11.3 do not apply and should have no impact on the timeline of this protest appeal.

It should be further noted that the plain language of Miss. Code Ann. § 25-61-5 contemplates the protective order process will take place *prior* to the filing of any protests: "the contract may be protested after execution." To find otherwise creates a process by which any party aggrieved by an award could file a protest and thereafter effectively hijack the protest process by making repeated unfounded and cumbersome public records requests and litigating the same. Such is the case here. MTM filed its protest of the IFB award to ModivCare on April 19, 2023. Now, two hundred and fifty two (252) days later, MTM's dispute over records from a disregarded bid continues. Because MTM's protest was made *prior* to institution of Verida's petition for protective order, Miss. Code Ann. §25-61-5 and Rule 3-202.11.3 do not apply and should have no impact on the timeline of this protest appeal.

Based upon its pleadings, MTM would have DFA and the PPRB believe that the information sought from Verida is critical to demonstrating that ModivCare's bid is both unreasonable and irresponsible; however, MTM has never actually confirmed the specific information it will receive from Verida upon conclusion of the protective order proceedings. While the court has not entered a written order, based upon information and belief, the court has issued a ruling in the matter ordering Verida to provide MTM with a copy of its current pending litigation. Momentarily setting aside that there is no statutory or regulatory authority for the stay requested by DFA staff, the actual information that is at the heart of that request is a list of Verida's litigation. Respectfully, how is such information relevant to this protest appeal? The answer is simple – it is not; but regardless, Verida did not appeal DOM's decision to reject its bid and any information related to Verida's bid is wholly irrelevant to the award to ModivCare and MTM's protest of the same.

Miss. Code Ann. § 25-61-5 provided DOM with the authority to deny the protest filed by MTM and move forward with awarding the IFB to ModivCare on October 4, 2023. Further, DFA staff has presented no statutory or regulatory authority supporting a stay of protest appeal proceeding. The PPRB should reject DFA staff's recommendation to stay and schedule the hearing for the earliest available setting.
