**NOTICE OF INTENT TO AWARD**

**Pest Control Services  
Preapproved Vendor List  
Invitation for Bids # 2025-01  
RFx # 3160007168**

The Public Procurement Review Board (PPRB) “may establish a preapproved list of providers of various personal and professional services for set prices with which state agencies may contract without bidding or prior approval from the board.” Miss. Code Ann. §27-104-7(2)(i). The Office of Statewide Strategic Sourcing (OSSS) at the Mississippi Department of Finance and Administration (DFA), on behalf of the PPRB, issued an Invitation for Bids (IFB) to establish a Preapproved Vendor List (PVL) for pest control services for use by state agencies under the purview of PPRB. OSSS received bids (attached) from the following bidders:

- Bay Pest Control Company, Inc.
- J.P.&G. dba Orkin Pest Control

OSSS reviewed the bids and determined that J.P.&G. LLC dba Orkin Pest Control was nonresponsive because it did not submit bid pricing in the required format.

OSSS will recommend that the PPRB place Bay Pest Control Company, Inc. on the Pest Control Services Preapproved Vendor List for all regions for which it submitted a bid. The PPRB is scheduled to review and vote on this recommendation on June 4, 2025. Upon approval by the PPRB, the PVL will be effective June 4, 2025 through May 31, 2028. Any Agency who has entered a contract with one of the PVL vendors prior to May 31, 2028 may extend that contract up to an additional two years, but not beyond May 31, 2030.

OSSS thanks all bidders for the time and effort put forth in submitting a bid and their interest in the pest control PVL. A bidder who responded to this IFB has an opportunity to request for reconsideration of the intent to award, which can be accomplished by referring to Section 4.4. of the IFB. Potential bidders are also referred to Section 4.5 of the IFB regarding potential future opportunities for rolling awards.
