# **NOTICE OF INTENT TO AWARD**

Lawn and Landscaping Services Preapproved Vendor List Invitation for Bids # 2022-03 RFx # 3160005040

The Public Procurement Review Board (PPRB) "may establish a preapproved list of providers of various personal and professional services for set prices with which state agencies may contract without bidding or prior approval from the board." Miss. Code Ann. §27-104-7(2)(i). The Office of Personal Service Contract Review (OPSCR) at the Mississippi Department of Finance and Administration (DFA), on behalf of the PPRB, issued an Invitation for Bids (IFB) to establish a Preapproved Vendor List (PVL) for lawn and landscaping services for use by state agencies under the purview of PPRB. OPSCR received bids from the following bidders:

- Greenco Lawn Service, LLC
- Gulf Breeze Landscaping, LLC
- Mississippi Yard Barber, LLC
- Rotolo Consultants, Inc.
- Simply Southern Solutions, Inc.
- Taylor Made Lawncare, Inc.
- TNT Lawn Care & Irrigation, Inc.

OPSCR reviewed the bids and determined that Taylor Made Lawn Care, Inc. was non-responsive because it does not provide all of the required services. All other bidders were deemed responsive and responsible. The following bidders' pricing exceeded the maximum allowed by Section 13.3 of the IFB in the regions indicated: Mississippi Yard Barber, LLC (Central); Rotolo Consultants, Inc. (North Delta); TNT Lawn Care & Irrigation, Inc. (East Central, Pinebelt, South Delta, and Southwest). OPSCR will recommend the following bidders be placed on the PVL in the regions indicated:
