Areas designated by the contracting agency shall be mulched with a 2-3 inch layer of pine straw, hardwood mulch, or pine bark mulch. The maintenance of a 2-3 inch layer does not mean that a 2-3 inch layer should be applied at any one time (unless none exists), but that the total layer should be maintained at that height.
