NOTICE OF INTENT TO AWARD

**Professional Nursing Services
Preapproved Vendor List
Invitation for Bids # 2022-04
RFx # 3160005563**

OPSCR established a preapproved vendor list (PVL) to provide professional nursing services as needed. On April 5, 2023, PPRB approved this professional nursing services list. As set forth in Section 4.4 of IFB No. 2022-04, OPSCR allowed for rolling awards by continuously accepting bids for potential placement on the PVL. The IFB provided that OPSCR would recommend awards to all responsive and responsible bidders whose average hourly rate is not more than 125% of the mean of the average hourly rate for the service category in the particular region. OPSCR determined the mean by only those bids submitted for inclusion on the original PVL. OPSCR received bids from the following bidders:

- Custom Healthcare Solutions, LLC
- DatamanUSA, LLC
- Health Advocates Network, Inc. dba Staff Today
- Infiniti Healthcare Services¹
- Management Registry, Inc. dba Malone Solutions
- Medical Edge Recruitment¹
- Millennial Healthcare, LLC
- Precision Healthcare Staffing, LLC¹
- StaffMD, LLC

OPSCR reviewed the bids and determined the following bidders non-responsive because they have not placed the minimum number of employees in the past two (2) years, and they did not score the minimum number of points from the references provided: DatamanUSA, LLC and Millennial Healthcare, LLC. Additionally, Medical Edge Recruitment, LLC withdrew their bid before the evaluations were completed.

All other bidders were deemed responsive and responsible.

Of those responsive and responsible bidders, two submitted pricing that exceeded the maximum allowed by Section 4.2.3 of the IFB in certain categories or regions. As a result, OPSCR is only recommending addition to the Preapproved Vendor List for the categories of service that fall within the allowable limits. (See **Attachment B: Vendors Who Exceeded the Maximum Bid Prices** for a list of these vendors and the regions and service categories in which their bids exceeded the maximum.)

OPSCR will recommend that the PPRB place the following bidders on the PVL:

- Custom Healthcare Solutions, LLC
- Health Advocates Network, Inc. dba Staff Today
- Infiniti Healthcare Services
- Management Registry, Inc. dba Malone Solutions
- Precision Healthcare Staffing, LLC
- StaffMD, LLC

The PPRB is scheduled to review and vote on this recommendation on May 7, 2025. Upon approval by the PPRB, the PVL will be effective July 1, 2023 through June 30, 2026. Any Agency who has entered a contract with one of the PVL vendors prior to June 30, 2026 may extend that contract up to an additional two years, but not beyond June 30, 2028.

OPSCR thanks all bidders for the time and effort put forth in submitting a bid and their interest in the professional nursing PVL. Bidders are referred to Section 5 of the IFB for additional information regarding post-award debriefings and protests.
