NOTICE OF INTENT TO AWARD

**Temporary Staffing Services
Preapproved Vendor List
Invitation for Bids # 2023-01
RFx # 3160005986**

OPSCR established a preapproved vendor list (PVL) to provide temporary staffing services on an as-needed basis. On October 4, 2023, PPRB approved this temporary staffing services list. As set forth in Section 4.4 of IFB No. 2023-01, OPSCR allowed for rolling awards by continuously accepting bids for potential placement on the PVL. The IFB provided that OPSCR would recommend awards be made to all responsive and responsible bidders whose average hourly rate is not more than 125% of the mean of the average hourly rate for that particular region. The mean was determined by only those bids submitted for inclusion on the original PVL. OPSCR received bids from the following bidders:

- Adelphi Medical Staffing, LLC
- ATC Healthcare Services, LLC
- Beatty's Services, Inc.
- LanceSoft, Inc.
- Openwork, LLC
- Precision Healthcare Staffing
- QLogic, LLC
- Sensatech, LLC
- Surge Staffing, LLC
- Vastek, Inc.

OPSCR deemed Vastek, Inc. non-responsive because they missed the bid submission deadline. Additionally, OPSCR deemed Surge Staffing, LLC non-responsive because they did not acknowledge all amendments to the Invitation for Bids. Finally, OPSCR determined Sensatech, LLC non-responsive because they did not score the minimum number of points from the references provided with their bid.

All other bidders were deemed responsive and responsible. Of those responsive and responsible bidders, two submitted pricing that exceeded the maximum allowed by Section 4.2.3 of the IFB. Adelphi Medical Staffing, LLC submitted pricing that exceeded the maximum in all regions and categories. ATC Healthcare Services, LLC submitted pricing that exceeded the maximum for General Office Support in the Central and Coastal Regions.

OPSCR will recommend that the PPRB place the following bidders on the PVL:

- ATC Healthcare Services, LLC
- Beatty's Services, Inc.
- LanceSoft, Inc.
- Openwork, LLC
- Precision Healthcare Staffing
- QLogic, LLC

The PPRB is scheduled to review and vote on this recommendation on November 6, 2024. Upon approval by the PPRB, the PVL will be effective November 6, 2024 through September 30, 2026. Any Agency who has entered a contract with one of the PVL vendors prior to September 30, 2026 may extend that contract up to an additional two years, but not beyond September 30, 2028.

OPSCR thanks all bidders for the time and effort put forth in submitting a bid and their interest in the temporary staffing PVL. Bidders are referred to Section 5 of the IFB for additional information regarding post-award debriefings and protests. Unsuccessful bidders are also referred to Section 4.4 of the IFB regarding potential future opportunities for rolling awards.
