The Public Procurement Review Board (PPRB) “may establish a preapproved list of providers of various personal and professional services for set prices with which state agencies may contract without bidding or prior approval from the board.” Miss. Code Ann. §27-104-7(2)(i). The Office of Personal Service Contract Review (OPSCR) at the Mississippi Department of Finance and Administration (DFA), on behalf of the PPRB, issued an Invitation for Bids (IFB) to establish a Preapproved Vendor List (PVL) for temporary staffing services for use by state agencies under the purview of PPRB. OPSCR received bids from the following bidders:

OPSCR reviewed the bids and determined that Netsynk, Inc. was non-responsible because they did not provide the required number of temporary staffing employee placements in the past two years. Additionally, OPSCR deemed WPA Healthcare Staffing, LLC non-responsive because they submitted the incorrect bid form. Finally, OPSCR determined the following non-responsible

because they did not score the minimum number of points from the references provided with their bid: Clovity, Compunnel, LanceSoft, RADgov, and Resource Logistics, Inc.

All other bidders were deemed responsive and responsible. Of those responsive and responsible bidders, five submitted pricing that exceeded the maximum allowed by Section 4.2.3 of the IFB. (See **Attachment A: Vendors Who Exceeded the Maximum Bid Prices** for a list of these vendors and the regions and service categories in which their bids exceeded the maximum.)

The PPRB is scheduled to review and vote on this recommendation on October 4, 2023. Upon approval by the PPRB, the PVL will be effective October 4, 2023 through September 30, 2026. Any Agency who has entered a contract with one of the PVL vendors prior to September 30, 2026 may extend that contract up to an additional two years, but not beyond September 30, 2028.

OPSCR thanks all bidders for the time and effort put forth in submitting a bid and their interest in the temporary staffing PVL. Bidders are referred to Section 5 of the IFB for additional information regarding post-award debriefings and protests. Unsuccessful bidders are also referred to Section 4.4 of the IFB regarding potential future opportunities for rolling awards.
