MDFA will schedule and/or suspend and reschedule the meeting at a time when a Representative of the Office of the Mississippi Attorney General can be present. Your request for debriefing must be

received within three (3) business days after the issuance of this notice or no later than close of business on Tuesday, April 1, 2025. Please refer to IFB Section 14.7 and Public Procurement Review Board Office Personal Service Contract Review (PPRB OPSCR) Rules and Regulations Section 5.6.2 for additional information regarding post-award vendor debriefings.

Vendors are reminded that any request for reconsideration of this decision must be submitted to the MDFA's Office of Insurance within seven (7) calendar days of the Notice of Intent to Award and posting of the Agency Procurement File or no later than close of business on Thursday, April 3, 2025. The request for reconsideration must be in writing and contain the requesting vendor's name, a single contact person, all contact information for the contact person, the RFx number of the solicitation, the date the IFB was issued, the date the Notice of Intent to Award was issued, and an explanation of the specific basis for the request, including the identification of which of these rules and regulations and/or the terms of the IFB the requesting vendor believes were violated by the Agency during the evaluation process, explain the factual basis for the alleged violation(s), and specify how the alleged violation(s) affected the outcome of the procurement. If you believe the Agency Procurement File posted on the Agency website is incomplete (i.e., does not contain a document or documents required by these rules and regulations), then state this in the request and specify what is believed to be missing. Should you believe the trade secrets and/or confidential commercial or financial information which were redacted from the Agency Procurement File posted on the Agency website contain issues related to your request, the state those concerns in the request - even if speculative - in a manner which is specific enough for MDFA to provide a response.
