### ORDER MODIFYING THE ORDER AMENDING THE FISCAL YEAR 2022-2023 BUDGET OF THE CITY OF JACKSON TO PROVIDE FOR THE TRANSFER OF FUNDS TO THE TORT CLAIMS FUND

WHEREAS, pursuant to Miss. Code Ann. § 11-46-17(2) each governmental entity other than political subdivisions shall participate in a comprehensive plan of self-insurance or one or more policies of liability insurance or combination of the two (2), all to be administered by the Department of Finance and Administration; and

WHEREAS, pursuant to Miss. Code Ann. § 11-46-17(2), each governmental entity participating in the plan shall make payments to the board in such amounts, times and manner determined by the board as the board deems necessary to provide sufficient funds to be available for payment by the board of the costs it incurs in providing coverage for the governmental entity; and

WHEREAS, pursuant to Miss. Code Ann. § 11-46-17(2) each governmental entity of the state other than the political subdivisions thereof participating in the plan procured by the board shall be issued by the board a certificate of coverage whose form and content shall be determined by the board but which shall have the effect of certifying that, in the opinion of the board, each of such governmental entities is adequately insured; and

WHEREAS, on or about December 12, 2022, the Tort Claims Board confirmed the City of Jackson Tort Fund was underfunded in the amount of \$1,140,929.00 for Fiscal Year 2022-2023; and

WHEREAS, the City of Jackson Budget needs to be amended to provide funding for these unbudgeted needs by moving funds from fund balance where they are needed to fund additional, unfunded needs of the Tort Fund; and

WHEREAS, the City of Jackson has worked with the Tort Claims Board to develop a payment plan to pay the underfunded balance in installments; and

WHEREAS, on January 17, 2023, the Jackson City Council approved an Order amending the budget of the City of Jackson to transfer funds in the amount of \$400,000.00 from the General Fund; and

WHEREAS, the City of Jackson and the Tort Claims Board have agreed that after transfer of the first installment, the remaining balance will be budgeted for payment in Fiscal Year 2023-2024 beginning October 1, 2023; and

WHEREAS, it is in the best interest of the City of Jackson to modify the prior Order transferring funds to cover the first installment to the Tort Claims Board; and

#### 4 RIDE A LONGS

These were new state trooper ride alongs from Class 66. Two were in Troop H (Meridian) and two were in Troop J (Hattiesburg). All four troopers had prior law enforcement experience. Safe driving techniques are observed with particular attention given to emergency response. I observed nothing that concerned me relative to risk management.

62 Site Visits - State Property/Leased Property Inspections

Agencies included were WIN Job Centers, Department of Health, welcome centers (Greenville and Woodville), Medicaid Regional Offices, Child Protection Services and Human Services. #### Dear Amanda:

Pursuant to your request I am submitting this report regarding the issues surrounding Trent McDowell's accident and injuries as well as the basis for settlement.

In this case, it is alleged by the Plaintiff that our client and driver for MDOT, while acting in the course and scope of his employment as a truck driver for MDOT caused a collision between Plaintiff and Defendant's vehicles. The accident occurred at the intersection of highway I-55 and Highway 24 in Pike County, Mississippi. Both parties agree that the Plaintiff and the MDOT driver Jerome Coleman exited I-55 at approximately the same time taking the off ramp and going down to the intersection of Highway 24 where they both encountered a red light. Coleman was in the left lane and the Plaintiff Trent McDowell was in the right lane. McDowell was driving a rented Dodge Charger; Coleman was driving an MDOT commercial vehicle that was headed to a repair shop to get some minor repair done to his vehicle. Both parties agree that when they came to a complete stop and when the light turned green, the Plaintiff testifies that he pulled off while staying in his lane the entire time and the MDOT employee, Coleman, also pulled off but veered into his lane and hit the Plaintiff pushing his car forward and then the Plaintiff states that Coleman hit his vehicle a second time, causing his vehicle to do a 180 into the middle of the road. Coleman's testimony is that the Plaintiff came over in his lane, the left lane, however he does admit that at that point he turned to the right and hit the Plaintiff a second time. There is no dispute that the Dodge Charger came to rest in the middle of the highway facing in the opposite direction when it came to rest.

Mr. Coleman's truck came to rest on the right side of the highway in the right lane.

As I have explained to you Mr. Coleman is not really sure as to how the accident occurred and why he hit the Plaintiff a second time. He testifies that he was traveling at a low rate of speed. As I have previously reported, Mr. Coleman's hesitation in his version of facts is problematic.

Based on the above stated facts and the testimony of Trent McDowell as well as the statement to me from Mr. Coleman I have advised you that I saw that we had exposure in this case.

We did have a witness who was a co-employee of MDOT named David Harper who was traveling behind Mr. Coleman, however, unfortunately, Mr. Harper was not watching ahead of him at the time the impact and says he did not see the initial impact, but he did however say that he saw Mr. Coleman "pushing" Mr. McDowell's vehicle down the highway and then saw Mr. Coleman veer to the right. He also stated that Mr. Coleman did not hit his brakes as near as he could tell.

Also, at the time of the accident, Mr. McDowell had his uncle Mike McDowell in the passenger side of the vehicle who was also hurt. We were unable to settle that claim.

### THE INJURIES

Mr. McDowell has seen multiple doctors at various times since the accident. He has had multiple imaging as well as injections and now ablation of his nerves. The first doctor that he saw three to four days after the accident was a Dr. Jolly who is a pain specialist in New Orleans. Dr. Jolly after interview and examination rated the pain of Mr. McDowell as 8/10. He documents that Mr. McDowell had difficulty walking, standing, bending and lifting and going upstairs. He also documented that Mr. McDowell had tingling and numbness in his foot. Dr. Jolly prescribed Ultram and Tramadol which are both pain medications. Dr. Jolly also prescribed rehabilitation with North Star Health Care. However, at this time it was during COVID-19 and all rehab was via tele-conference. Dr. Jolly diagnosed that the therapy did not work, thereafter the Plaintiff went to see Dr. Cenac who is an orthopedic surgeon in Homa, Louisiana. Dr. Cenac is related with Gulf Coast Orthopedics. Dr. Cenac treated the Plaintiff between May 20, 2020 until April 7, 2021. Dr. Cenac ordered an MRI on May 11, 2020. The MRI test found "interior osteophytes and desiccation particularly from the broad-based central disc protrusions effacing the sac with mild decrease and foramina.... changes to the MM bulge at L-4-5 with mild decrease in fat nutria foramina. One MM bulge at L5 S1. Disc desecration and interior osteophytes and infused disc bulge and facet changes at L3-L4- to L5-S1 also narrowing of neural foramina and significant level 3-4 with a central annular tear."

An annular tear is where the disc which lies between the veratrum is actually injured or torn. If you have an annular tear to the disc, it can allow fluid to leak out and bone to hit bone. You can have different levels of an annular tear. If an annular tear gets worse you have to have surgery to repair it.

Dr. Cenac is of the opinion that the accident obviously is the cause of the problem, because there were no prior symptoms pre-accident. Again, an annular tear is an objective finding and not just the opinion of the doctor. Dr. Cenac tried conservative therapy. He prescribed physical therapy but the Plaintiff testified that this didn't work and was thereafter discontinued. Thereafter Dr. Cenac ordered a nerve conduction study done by a Dr. Donald Gervais. The report on the nerve study was that the ENG nerve studies point to a chronic left S-1 radiculopathy. Dr. Cenac saw him again on December 21, 2020 and wanted to refer him to a Dr. Haddell for an epidural. Plaintiff has testified he has now had five epidurals by Dr. Haddell. Plaintiff testified that the epidurals did no good and Mr. McDowell described them as being very painful.

Thereafter Dr. Cenac ordered updated MRIs on March 31, 2021 and the findings of the MRIs were:

"(1) T12-L1, L1-2 and L2-3 show no compression disc abnormality; (2) L3-4 shows mixed disc protrusion centrally (annular tear) with no nerve root effacement (no change); (3) L4-5 shows mixed disc protrusion (annular tear) nerve root effacement (no change); (4) L5-S1 shows mixed disc protrusion (third annular tear). No nerve root effacement"

As I indicated in prior reports, it now appears that there are not one, but three annular tears diagnosed in the Plaintiff. This procedure was done in Open MRI of Louisiana in Homa, Louisiana. The last visit documented by Dr. Cenac is as follows:

"At the present I do feel that the Plaintiff's option from a physical standpoint is to have 3-level lumbar anterior posterior spinal fusions with the procedure to remove the discs and restore his foramina height and sagittal balance.... He is upset at his situation."

Dr. Cenac then went on to state that if the surgery is performed, he will have very limited capacity

to be employed in the future. It is Dr. Cenac's opinion that all three annular tears are related to the accident.

As I further explained in the prior reports, the reason McDowell does not want to have the spinal fusion is that it will preclude him from completely going back to work as a seaman. However, Dr. Cenac is of the opinion that his situation will not get better, but will only worsen.

On August the 20 2021 Mr. McDowell went back to Dr. Jolly who is the pain specialist. Dr. Jolly referred him to a Dr. Brennan who is an orthopedic surgeon in Lafayette, Louisiana. Mr. McDowell testified that he was looking for other doctors who would hopefully give him a better prognosis than the surgery that Dr. Cenac wanted to conduct. The following is a quote from Dr. Brennan report:

"He has been through physical therapy with no improvement, he had lumbar injections with no improvement and ultimately had a lumbar disc o gram showing concorded pain in the L3, L4, and L5-S1 regions with equivocal findings in L4-5. His lumbar MRI scan showed lumbar degenerative disc disease and annular tearing of the lower three lumbar segments.... I told him that the positive fabere testing on the left indicated a joint-mediated pain possibly and I thought before embarking on a multi-level lumbar stabilization procedure that a left S side joint injection block would be helpful in determining the contribution of any S side joint to his pain syndrome. He understands that. I will order the left sacroiliac joint block and I will create a "for the L3-S1 laminectomy infusion based on the results of the discogram".

At the time of the mediation the Plaintiff had still not had the laminectomy infusion. However, once this is done, he will no longer be able to work as a seaman.

### **UPDATED MEDICAL**

Since the mediation in November, the Plaintiff has undergone a Radio Frequency Ablation, which is in essence the burning of nerves in his back. This was performed in December 2022. The report from Dr. Susan Bryant is that the procedure gave Plaintiff some relief in his numbness of his foot (which she also adds is "unusual") it virtually did no good for his back.

His latest visit in January 2023 he complained of constant pain that was "sharp", "shooting", "stabbing" and "constant pressure". He is on a regiment of opioids. His next procedure will be lumbar fusion, which as stated, will cause the end of his career as a seaman. The Plaintiff is in his late 30's by the way.

#### JOB HISTORY

At the time of the accident Plaintiff was working for Brossard Oil Transportation out of New York. He was classified as a seaman thus making about 550.00 per day and over 100,000.00 per year. As a classified merchant- marine this allowed him to work on ships and he was considered a seaman who engaged in "heavy lifting" chipping and painting. He was also in loading and unloading cargo. He was also licensed and qualified to deal with all facets of liquid cargo as it relates to the oil industry. He has not worked since the accident and thus claiming lost wages and current medical to date exceeded \$250,000.00.

Based upon the severity of the injuries and based upon the fact that two doctors have confirmed that he needs a fusion of his lumbar spine, and based upon the fact that such an operation would thereafter cause him to be unemployable as a mariner seaman. I feel the settlement of \$275,000.00 was very favorable to MDOT. The Plaintiff's medical expenses are at present over \$60,000.00 and expected to go well over \$100,000.00.

Therefore, in view of the liability, coupled with the severity of the injuries a pinion of \$275,000.00 was a very good settlement under all the circumstances.

### CONCLUSION

This young African American man makes a very good witness and comes across as very genuine. He has lost substantial wages to date and will lose substantial more in the future. The settlement is warranted under all the facts.
